1. **Short Title and Commencement** - (1) These rules may be called the Indian Petroleum and Explosives Safety Service (Amendment) Rules, 2024
(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Indian Petroleum and Explosives Safety Service Rules, 2021 (hereinafter referred to as said rules), in Definition following shall be inserted namely:-

(l) "**Deputation**" means an officer from outside can come for a limited period, by the end of which will have to revert to his parent cadre.
