FDI SYNOPSIS ON COUNTRY SINGAPORE

(As on 31.12.2023)

CUMULATIVE FDI INFLOW:

➤ **Cumulative FDI equity inflow** from all Countries in India during the period from January 2000 to December 2023 is **USD 667.14 billion**, excluding amount remitted on RBI's-NRI Schemes. These FDI inflow do not include country-wise data on 'Re-invested earnings' and 'Other capital', which are, not maintained by RBI.

BRIEF NOTE ON FOREIGN DIRECT INVESTMENT (FDI) FROM SINGAPORE

An analysis of the foreign direct investment (FDI) equity inflow, received in India, since 2000, shows that the FDI equity inflow have risen substantially.

2. CUMULATIVE FDI EQUITY INFLOW (*remittance-wise*) received during **January 2000 – December 2023** were INR 4,246,999.09 crores (USD 667.14 billion). Out of this, **FDI inflow** from Singapore (*which ranks 2nd*) are **INR 10,55,907.05 crores** (i.e. **USD 155.61 billion**), which represents 23.33% of the cumulative inflow received (this amount does not include inflow received prior to January 2000, as such data prior to that date was not centrally maintained by the RBI).

3. YEAR-WISE FDI EQUITY INFLOW received from Singapore since January, 2000, as compared to total equity inflow is given below:

4.1. SECTOR-WISE DISTRIBUTION OF FDI INFLOW:

On perusal of the sector-wise distribution of **FDI equity inflow** received from Singapore, from 01.01.2000 to 31.12.2023, it is seen that the highest FDI equity inflow have been in the Services Sector, which accounts for about 19% of FDI inflow from Singapore. Computer software & Hardware, with over 17%, is in the 2nd place and, Trading is over 13%, is in the 3rd place.
