FDI SYNOPSIS ON EUROPEAN UNION COUNTRIES

(As on 31.12.2024)

➤ **Cumulative FDI equity inflow** from all countries in India during the period from January 2000 to December 2024 is **USD 720.20 billion**, excluding amount remitted on RBI's-NRI schemes. **These FDI inflows do not include country-wise data on Re-invested earnings' and 'Other capital', which are, not maintained by RBI.**

- **FDI equity inflow USD 720.20 billion** reported from all countries, out of these:
- **SHARE OF EUROPEAN UNION COUNTRIES IN FDI EQUITY INFLOW FROM JANUARY 2000 TO DECEMBER 2024**
 - **Percentage share:** 16.55%

DETAILED NOTE ON FDI EQUITY INFLOW REPORTED FROM EUROPEAN UNION COUNTRIES

An analysis of the foreign direct investment (FDI) equity inflow, reported in India, since 2000, shows that the FDI equity inflow have risen substantially. European Union are **Austria, Belgium, Bulgaria, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Ireland, Italy, Latvia, Lithuania, Luxembourg, Malta, Netherlands, Poland, Portugal, Romania, Slovakia, Slovenia, Spain, Sweden**. The total year-wise Inflow figures for the above countries are **Annex**

2. **CUMULATIVE FDI EQUITY INFLOW** (remittance-wise) received during January 2000-December 2024 were **INR 46,90,830.10 crore (USD 720.20 billion)**. Out of this, FDI inflow from EUROPEAN UNION Countries are **INR 7,78,442.51 crore (i.e. USD 119.16 billion)**, which represents 16.55% of the cumulative inflow received (this amount does not include inflow received prior to January 2000, as such data prior to that date was not centrally maintained by the RBI).

4.1 SECTOR-WISE DISTRIBUTION OF FDI INFLOW:

On perusal of the sector-wise distribution of FDI equity inflow reported from EUROPEAN UNION Countries, from 01.01.2000 to 31.12.2024, it is seen that the highest FDI equity inflow has been in the Services Sector, which accounts with over 15% of FDI inflow. This is followed by the Computer software & hardware sector at around 11% and Automobile Industry sector at around 8% of the inflow.
